CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HERBERT J. and JACQUELINE M. HESTER, JERRY JONES and JOE QUINN, DRY CANYON FARMS, and DWAYNE ROSEBROOK 2696 SOUTHWEST BENTWOOD DRIVE REDMOND, OREGON 97756

confirms the right to use the waters of FIVE WELLS in the DEEP CANYON CREEK BASIN for the purpose of IRRIGATING 239.5 ACRES.

This right was perfected under Permit G-7360. The date of priority is DECEMBER 15, 1976. This right is limited to 2.991 CUBIC FEET PER SECOND, BEING 0.15 CFS FROM WELL 3, 0.003 CFS FROM WELL 5, 0.002 CFS FROM WELL 6, 0.786 CFS FROM WELL 8, AND 2.05 CFS FROM WELL 4, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 SW 1/4, NE 1/4 NE 1/4, SE 1/4 NE 1/4, SECTION 20, T 14 S, R 12 E, W.M.; WELL 4 - 1050 FEET NORTH AND 170 FEET EAST FROM THE SW CORNER OF SECTION 20; WELL 5 - 300 FEET SOUTH AND 40 FEET WEST, WELL 6 - 1260 FEET SOUTH AND 40 FEET WEST, WELL 8 - 2350 FEET SOUTH AND 1060 FEET WEST, ALL FROM THE NE CORNER OF SECTION 20; NE 1/4 NE 1/4, SECTION 35, T 14 S, R 11 E, W.M.; WELL 3 - 5520 FEET SOUTH AND 770 FEET WEST FROM THE NE CORNER OF SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
