CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS in the LOST RIVER BASIN for the purpose of IRRIGATING 444.0 ACRES.

This right was perfected under Permit G-7465. The date of priority is APRIL 25, 1977. This right is limited to 5.55 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 SW 1/4, SECTION 22, NE 1/4 SE 1/4, SECTION 27, T 38 S, R 11 E, W.M.; WELL #1 - 400 FEET NORTH AND 90 FEET WEST FROM THE S 1/4 CORNER OF SECTION 22, WELL #2 - 200 FEET SOUTH AND 760 FEET WEST FROM THE E 1/4 CORNER OF SECTION 27.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
