CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SIX WELLS in the WILLAMETTE RIVER BASIN for the purpose of the PRIMARY IRRIGATION OF 189.4 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 9.8 ACRES.

This right has been perfected under Permit G-10283. The date of priority is OCTOBER 14, 1983. This right is limited to 2.49 CUBIC FEET PER SECOND BEING 0.24 CFS FROM WELL 1, 0.46 CFS FROM WELL 2, 0.25 CFS FROM WELL 3, 0.68 CFS FROM WELL 4, 0.82 CFS FROM WELL 5, 0.04 CFS FROM WELL 6 or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NW 1/4 SW 1/4, SW 1/4 SW 1/4, SE 1/4 SW 1/4, LOT 4 (NE 1/4 SE 1/4), LOT 4 (SE 1/4 SE 1/4), SECTION 31, T 14 S, R 4 W, W.M.; WELL 2 - 2000 FEET NORTH AND 1380 FEET EAST, WELL 1 - 640 FEET NORTH AND 900 FEET EAST, WELL 3 - 1280 FEET NORTH AND 2230 FEET EAST, WELL 4 - 730 FEET NORTH AND 2290 FEET EAST, ALL FROM THE SW CORNER OF SECTION 31; WELL 6 - 1380 FEET NORTH AND 1120 FEET WEST, WELL 5 - 700 FEET NORTH AND 1000 FEET WEST; BOTH FROM THE SE CORNER OF SECTION 31.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
