CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of AN UNNAMED SLOUGH AND INGRAM ISLAND SLOUGH, tributaries of the WILLAMETTE RIVER, for the purpose of IRRIGATING 25.3 ACRES.

This right has been perfected under Permit 48113. The date of priority is OCTOBER 14, 1983. This right is limited to 0.32 CUBIC FOOT PER SECOND BEING 0.20 CFS FROM INGRAM ISLAND SLOUGH AND 0.12 CFS FROM THE UNNAMED SLOUGH, or its equivalent in case of rotation, measured at the point of diversion from the sources.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 31, SW 1/4 SW 1/4, SECTION 32, T 14 S, R 4 W, W.M.; INGRAM ISLAND SLOUGH - 450 FEET NORTH AND 830 FEET EAST FROM THE SW CORNER OF SECTION 31, UNNAMED SLOUGH - 1160 FEET NORTH AND 560 FEET EAST FROM THE SW CORNER OF SECTION 32.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
