CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO UNNAMED STREAMS AND RESERVOIR, CONSTRUCTED UNDER PERMIT R-5977, a tributary of LITTLE BUTTE CREEK, for the purpose of IRRIGATING 32.6 ACRES AND RECREATION.

The right has been perfected under Permit 36830. The date of priority is MARCH 29, 1972. The right is limited to not more than 0.42 CUBIC FOOT PER SECOND; BEING 0.01 CFS FOR RECREATION AND 0.26 CFS FOR IRRIGATION FROM WEST UNNAMED CREEK AND 0.01 CFS FOR RECREATION AND 0.14 CFS FOR IRRIGATION FROM EAST UNNAMED CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NW 1/4, SECTION 13, NE 1/4 NE 1/4, SECTION 14, T 36 S, R 1 E, W.M.; EAST UNNAMED CREEK - 1000 FEET SOUTH AND 10 FEET EAST, WEST UNNAMED CREEK - 730 FEET SOUTH AND 550 FEET WEST BOTH FROM THE NW CORNER OF SECTION 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and the reservoir.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

TOWNSHIP 36 SOUTH, RANGE 1 EAST, W.M.		

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
