CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM C. AND NONDYS V. WOOLEY ROUTE 1, BOX 303 DRAIN, OREGON 97435

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-6266, a tributary of PASS CREEK, for the purpose of the PRIMARY IRRIGATION OF 5.9 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 5.5 ACRES.

This right has been perfected under Permit 39117. The date of priority is APRIL 30, 1973. This right is limited to 0.07 CUBIC FOOT PER SECOND FROM DIRECT FLOW AND 8 ACRE FEET STORED WATER ONLY FOR LANDS DESCRIBED AS SUPPLEMENTAL or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, SECTION 33, T 21 S, R 5 W, W.M.; 650 FEET NORTH AND 350 FEET WEST FROM THE SE CORNER OF SECTION 33.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from direct flow and 2.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
