CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALLEN CANYON SPRINKLER ASSOCIATION ROUTE 1 WALLOWA, OREGON 97885

confirms the right to use the waters of the LOSTINE RIVER, a tributary of the WALLOWA RIVER, for the purpose of the PRIMARY IRRIGATION OF 25.0 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 254.0 ACRES.

This right has been perfected under Permit 38052. The date of priority is MAY 7, 1973. This right is limited to 6.43 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SE 1/4, SECTION 27, T 1 S, R 43 E, W.M.; 2870 FEET SOUTH AND 220 FEET EAST FROM THE N 1/4 CORNER OF SECTION 27.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
