CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the SOUTH YAMHILL RIVER, a tributary of the YAMHILL RIVER, for the purpose of THE SUPPLEMENTAL IRRIGATION OF 98.4 ACRES.

This right has been perfected under Permit 38520. The date of priority is FEBRUARY 15, 1974 FOR 0.34 CFS AND JULY 1, 1974 FOR 0.89 CFS. This right is limited to 1.23 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 10 (SE 1/4 SW 1/4), SECTION 6, T 5 S, R 4 W, W.M.; 1250 FEET NORTH FROM THE NE CORNER OF DLC 65.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
