confirms the right to use the waters of ELK RIVER AND TWO SPRINGS, a tributary of PACIFIC OCEAN, for the purpose of DOMESTIC USE FOR THREE FAMILIES, STOCKWATER AND IRRIGATION OF 64.9 ACRES.

The right has been perfected under Permit 41917. The date of priority is MAY 11, 1977. The right is limited to not more than 0.83 CUBIC FOOT PER SECOND, BEING 0.8 CFS FROM ELK RIVER FOR IRRIGATION, 0.005 CFS FOR DOMESTIC AND 0.005 CFS FOR STOCK FROM SPRING 4, AND 0.01 CFS FOR DOMESTIC USE AND 0.005 CFS FOR STOCK FROM SPRING 5, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

RIVER- SE 1/4 NW 1/4, SECTION 21, 450 FEET NORTH AND 2280 FEET EAST, SPRING 4,NE 1/4 SW 1/4, SECTION 21, 50 FEET SOUTH AND 1400 FEET EAST, SPRING 5, SW 1/4 NW 1/4, SECTION 21, 1230 FEET NORTH AND 650 FEET EAST ALL FROM THE W 1/4 CORNER OF SECTION 21, T 32 S, R 15 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 4.4 ACRES SW 1/4 NW 1/4 24.9 ACRES, DOMESTIC AND STOCK SE 1/4 NW 1/4 16.4 ACRES, DOMESTIC AND STOCK NE 1/4 SW 1/4 5.2 ACRES

NW 1/4 SE 1/4 14.0 ACRES

SECTION 21 TOWNSHIP 32 SOUTH, RANGE 15 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
