## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WEBSTER BRIGGS 4422 GAZLEY ROAD MYRTLE CREEK, OREGON 97457

confirms the right to use the waters of the SOUTH UMPQUA RIVER, a tributary of UMPQUA RIVER, for IRRIGATING 76.4 ACRES.

This right was perfected under Permit 49872. The date of priority is JANUARY 22, 1985. This right is limited to 0.96 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 1 (NE 1/4 NE 1/4), SECTION 27, LOT 9 (SW 1/4 SW 1/4), SW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 56, SECTION 23, T 30 S, R 5 W, W.M.; 220 FEET SOUTH AND 1280 FEET WEST, 150 FEET NORTH AND 1000 FEET EAST, 800 FEET NORTH AND 3090 FEET EAST, ALL FROM THE SW CORNER OF SECTION 23.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
