CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the PUDDING RIVER BASIN for the purpose of the PRIMARY IRRIGATION OF 6.5 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 9.1 ACRES.

This right has been perfected under Permit G-7862. The date of priority is AUGUST 10, 1977. This right is limited to 0.20 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 53, SECTION 35, T 4 S, R 1 W, W.M.; 680 FEET NORTH AND 330 FEET EAST FROM THE SW CORNER OF DLC

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

WATER FROM THE WELL MAY BE PLACED INTO AN UNNAMED STREAM AND REDIRECTED AT A POINT LOCATED IN THE SW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 53, SECTION 36; 390 FEET NORTH AND 1680 FEET EAST FROM THE SW CORNER OF DLC 53. The amount of water rediverted from the channel of the unnamed stream shall not exceed the amount by which the flow of the unnamed stream, at the point of rediversion, is increased above the natural flow Measuring devices shall be installed by the operation of said well. when and as directed by the watermaster.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
