CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALBERT R. WASSON 4000 BROWNS CREEK ROAD THE DALLES, OREGON 97058

confirms the right to use the waters of TWO SPRINGS, a tributary of BROWNS CREEK, for the purpose of DOMESTIC USE FOR ONE FAMILY AND THE PRIMARY IRRIGATION OF 10.7 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 2.6 ACRES.

This right has been perfected under Permit 38128. The date of priority is FEBRUARY 1, 1974. This right is limited to 0.225 CUBIC FOOT PER SECOND BEING 0.16 CFS FOR IRRIGATION FROM SPRING 1 AND 0.06 CFS FOR IRRIGATION AND 0.005 CFS FOR DOMESTIC FROM SPRING 2 or its equivalent in case of rotation, measured at the points of diversion from the springs.

The points of diversion are located as follows:

NE 1/4 NE 1/4, SE 1/4 NE 1/4, SECTION 11, T 1 N, R 12 E, W.M.; SPRING 1 - 1180 FEET SOUTH AND 880 FEET WEST, SPRING 2 - 1570 FEET SOUTH AND 960 FEET WEST BOTH FROM THE NE CORNER OF SECTION 11.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
