CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MEADOW LAKE INC.

confirms the right to use the waters of WELLS 1 AND 2 in the SWAN LAKE BASIN for the purpose of IRRIGATING 139.0 ACRES, BEING 36.1 ACRES FROM WELL 1 AND 102.9 ACRES FROM WELL 2.

This right has been perfected under Permit G-10610. The date of priority is MARCH 17, 1986. This right is limited to 1.74 CUBIC FOOT PER SECOND BEING 0.45 CFS FROM WELL 1 AND 1.29 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SW 1/4 SE 1/4, NW 1/4 NW 1/4, SECTION 16, T 38 S, R 10 E, W.M.; WELL 1 - 2000 FEET SOUTH AND 60 FEET WEST, WELL 2 - 2050 FEET NORTH AND 3770 FEET WEST BOTH FROM THE W 1/4 CORNER OF SECTION 16.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
