CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THE CITY OF ROSEBURG
900 S.E. DOUGLAS STREET
ROSEBURG, OREGON 97470

confirms the right to use the waters of THE SOUTH UMPQUA RIVER, a tributary of THE UMPQUA RIVER, for the purpose of IRRIGATING 36.5 ACRES.

The right has been perfected under Permit 45076. The date of priority is MAY 9, 1980. The right is limited to not more than 0.46 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SE 1/4, SE 1/4 SE 1/4, BOTH WITHIN DLC 53, SECTION 14, T 27 S, R 6 W, W.M.; DIVERSION 1 - 700 FEET NORTH AND 1720 FEET WEST, DIVERSION 3 - 930 FEET NORTH AND 130 FEET WEST, BOTH FROM THE SE CORNER OF SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
