## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PAUL E. AND LEEANN HOLDERNESS 2170 UPPER RIVER ROAD GOLD HILL, OREGON 97525

confirms the right to use the waters of LOST CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-8142, a tributary of the PACIFIC OCEAN, for the purpose of the SUPPLEMENTAL IRRIGATION OF 10.1 ACRES.

This right has been perfected under Permit 45889. The date of priority is JULY 15, 1981. This right is limited to 16.5 ACRE FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 11, T 36 S, R 3 W, W.M.; RIVER - 190 FEET NORTH AND 770 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 11. LOST CREEK RESERVOIR - SW 1/4 NW 1/4 AND W 1/2 SW 1/4, SECTION 26, T 33 S, R 1 E, W.M.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 4.5 acre-feet (or its equivalent) for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein and is subject to the terms and conditions of Contract 1-07-10-W0305 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Department.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

SW 1/4 NW 1/4 2.1 ACRES NE 1/4 SW 1/4 2.4 ACRES NW 1/4 SW 1/4 5.6 ACRES SECTION 11 TOWNSHIP 36 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
