CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DEPARTMENT OF FISH AND WILDLIFE P.O. BOX 59 PORTLAND, OREGON 97207

confirms the right to use the waters of SPRINGS 1 AND 3 AND DRAINAGE TILE, tributaries of CLEAR CREEK, for the purpose of THE PRIMARY IRRIGATION OF 3.6 ACRES, THE SUPPLEMENTAL IRRIGATION OF 30.9 ACRES, AND DOMESTIC USE FOR ONE FAMILY.

This right has been perfected under Permit 42717. The date of priority is APRIL 7, 1977 FOR IRRIGATION AND OCTOBER 24, 1977 FOR DOMESTIC USE. This right is limited to 0.865 CUBIC FOOT PER SECOND BEING 0.86 CFS FOR IRRIGATION BEING 0.20 CFS EACH FROM THE SPRINGS AND 0.46 CFS FROM THE DRAINAGE TILE AND 0.005 CFS FOR DOMESTIC USE FROM SPRING 1, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SW 1/4, NW 1/4 SW 1/4, SW 1/4 SW 1/4, SECTION 2, T 8 S, R 38 E, W.M.; TILE (POND) - 1580 FEET NORTH AND 2550 FEET EAST, SPRING 3 - 1850 FEET NORTH AND 1270 FEET EAST, SPRING 1 - 160 FEET NORTH AND 1230 FEET EAST ALL FROM THE SW CORNER OF SECTION 2.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
