CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SPRING CREEK, a tributary of WILLIAMSON RIVER, for the purpose of DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 0.06 ACRE.

The right has been perfected under Permit 42356. The date of priority is MAY 25, 1977. The right is limited to not more than 0.01 CUBIC FOOT PER SECOND BEING 0.005 CFS FOR DOMESTIC AND 0.005 CFS FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 4, T 34 S, R 7 E, W.M.; 970 FEET SOUTH AND 1010 FEET WEST FROM EAST 1/4 CORNER SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. RECORD HOLDER IS HEREBY PUT ON NOTICE THAT, BECAUSE THIS CERTIFICATE IS JUNIOR IN PRIORITY TO ALL OTHER RIGHTS ON THE KLAMATH RIVER, EXISTING BEFORE THE DATE OF THE FILING OF APPLICATION NO. 55971, AND THAT THE WATER AVAILABLE MIGHT BE LESS THAN THE AMOUNT STATED HEREIN IF RUNOFF IN THE KLAMATH RIVER BASIN IS INSUFFICIENT TO SATISFY ALL RIGHTS WITH SENIOR PRIORITY, INCLUDING THOSE OF THE UNITED STATES UNDER ITS 1905 FILINGS, THE KLAMATH RIVER COMPACT, OR UNDER THE DECREE OF A COURT OF COMPETENT JURISDICTION.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 0.06 ACRE AND DOMESTIC
SECTION 4
TOWNSHIP 34 SOUTH, RANGE 7 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
