CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LEO H. ALBERTSON

confirms the right to use the waters of AN UNNAMED DRAINAGE WAY, a tributary of GOOSE LAKE, for the purpose of PRIMARY IRRIGATION OF 16.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 13.9 ACRES.

The right has been perfected under Permit 45806. The date of priority is JANUARY 19, 1981. The right is limited to not more than 0.75 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 8, T 40 S, R 19 E, W.M.; 1980 FEET SOUTH AND 2710 FEET WEST FROM THE NE CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. THE RIGHT ALLOWED HEREIN SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT EXISTING FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN. THIS RIGHT IS SUBJECT TO THE TERMS AND CONDITIONS OF A STIPULATION WITH LAKEVIEW WATER USERS, INC. DATED MARCH 2, 1981, RECORDED AT VOLUME 6, PAGE 884, MISCELLANEOUS RECORDS OF THE WATER RESOURCES DIRECTOR.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

TOWNSHIP 40 SOUTH, RANGE 19 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
