CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHRISTMAS VALLEY PARK & RECREATION CHRISTMAS VALLEY 97641

confirms the right to use the waters of A WELL in the CHRISTMAS LAKE BASIN for IRRIGATING 72.2 ACRES AND MAINTAINING CHRISTMAS VALLEY LAKE FOR RECREATION.

This right was perfected under Permit G-1950. The date of priority is SEPTEMBER 7, 1961. This right is limited to 1.41 CUBIC FEET PER SECOND; BEING 0.91 CFS FOR IRRIGATION AND 0.50 CFS FOR MAINTAINING THE LAKE, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 SE 1/4, SECTION 10, T 27 S, R 17 E, W.M.; WELL 2 - 1230 FEET NORTH AND 990 FEET WEST FROM THE SE CORNER OF SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
