CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MUD SPRINGS CREEK, a tributary of TROUT CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 9.6 ACRES.

The right has been perfected under Permit 43003. The date of priority is JUNE 16, 1977. The right is limited to not more than 0.2 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 20, T 9 S, R 14 E, W.M.; 1390 FEET NORTH AND 3580 FEET WEST FROM SE CORNER OF SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 6.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT ALLOWED HEREIN SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT EXISTING FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN, PROVIDED FURTHER THAT, ALTHOUGH DECLARED HEREIN TO BE FOR SUPPLEMENTAL IRRIGATION, THE RIGHT ALLOWED MAY, IN THE INTEREST OF CONSERVING THE GROUND WATER SUPPLIES, BE EXERCISED AT TIMES WHEN WATER IS AVAILABLE IN THE GROUND WATER SUPPLY, PROVIDED THAT THE TOTAL QUANTITY DIVERTED FROM ALL SOURCES OF SUPPLY DOES NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SW 1/4 7.9 ACRES
NW 1/4 SW 1/4 1.7 ACRES
 SECTION 20
TOWNSHIP 9 SOUTH, RANGE 14 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
