CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of DAIRY CREEK, a tributary of the CHEWAUCAN RIVER, for the purpose of ROAD WATERING.

The right has been perfected under Permit 49464. The date of priority is SEPTEMBER 26, 1984. The right is limited to not more than 1.0 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source, and shall be limited to a total appropriation of 3.07 acre-feet per year.

The point of diversion is located as follows:

SE 1/4 SE 1/4, SECTION 31, T 35 S, R 17 E, W.M.; NORTH 26 DEGREES WEST 905 FEET FROM THE SE CORNER OF SECTION 31.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
