CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALAN M. AND RUTH G. INSKO
ROUTE 1, BOX 3600
PILOT ROCK, OREGON 97868

confirms the right to use the waters of JACOB'S WELL in the MCKAY CREEK BASIN for PRIMARY IRRIGATION OF 23.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 8.3 ACRES.

This right was perfected under Permit G-5470. The date of priority is NOVEMBER 18, 1974. The right is limited to 0.41 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

LOT 16 (SE 1/4 SE 1/4), SECTION 1, T 1 S, R 32 E, W.M.; 440 FEET NORTH AND 1200 FEET WEST FROM THE SE CORNER OF SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
