## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARIE AND ELSO DEJONG ROUTE 1, BOX 202 BONANZA, OREGON 97623

confirms the right to use the waters of TWO WELLS in the LOST RIVER BASIN for the purpose of IRRIGATING 128.8 ACRES.

The right has been perfected under Permit G-9436. The date of priority is AUGUST 27, 1981. The right is limited to not more than 1.61 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 NE 1/4, SECTION 21, NW 1/4 NW 1/4, SECTION 22, T 39 S, R 11 E, W.M.; WELL 1 - 2300 FEET SOUTH AND 140 FEET WEST, WELL 2 - 450 FEET SOUTH AND 800 FEET EAST BOTH FROM THE NW CORNER OF SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. In the event of a request for a change in point of appropriation, an additional point of appropriation, or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
