CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of AN UNNAMED DRAINAGEWAY AND MOHNEY RESERVOIR, CONSTRUCTED UNDER PERMIT R-6397 AND ENLARGED UNDER PERMIT R-10506, tributaries of SOUTH YAMHILL RIVER, for the purpose of IRRIGATING 8.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 28.5 ACRES.

The right has been perfected under Permit 49379. The date of priority is MAY 15, 1985. The right is limited to not more than 0.10 CUBIC FOOT PER SECOND AND STORED WATER ONLY ON THE LANDS DESCRIBED AS SUPPLEMENTAL or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 15, T 6 S, R 6 W, W.M.; 2230 FEET SOUTH AND 2130 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre FROM DIRECT FLOW, and shall be further limited to a diversion of not to exceed 2.5 acre-feet PER ACRE FOR EACH ACRE IRRIGATED DURING THE IRRIGATION SEASON OF EACH YEAR from direct flow and storage.

THE RIGHT SHALL conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
