CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HARRY STRAIN 47721 FLORAS LAKE LOOP LANGLOIS, OREGON 97450

confirms the right to use the waters of AN UNNAMED STREAM, JIM CREEK AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-9534, a tributary of FLORAS CREEK, for the purpose of IRRIGATING 30.0 ACRES AND STOCK.

The right has been perfected under Permit 48298. The date of priority is OCTOBER 14, 1983. The right is limited to not more than 0.383 CUBIC FOOT PER SECOND BEING 0.19 CFS FOR IRRIGATION AND 0.003 CFS FOR STOCK WATER FROM JIM CREEK AND RESERVOIR AND 0.19 CFS FOR IRRIGATION FROM UNNAMED STREAM or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NW 1/4, SECTION 10, T 31 S, R 15 W, W.M.; RESERVOIR - 1280 FEET NORTH AND 1900 FEET EAST, JIM CREEK - 510 FEET NORTH AND 2600 FEET EAST, PORTABLE PUMPING BETWEEN POINTS 420 FEET NORTH AND 1920 FEET EAST, AND 70 FEET NORTH AND 1850 FEET EAST, ALL FROM THE W 1/4 CORNER OF SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre FROM DIRECT FLOW, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year FROM DIRECT FLOW AND STORAGE.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NW 1/4 30.0 ACRES AND STOCK SECTION 10
TOWNSHIP 31 SOUTH, RANGE 15 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
