CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MISSION CREEK, and a reservoir constructed under Permit R-5248, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATING 77.6 ACRES.

The right has been perfected under Permit 49700. The date of priority is APRIL 25, 1986. The right is limited to not more than 0.97 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 7 (SE 1/4 SE 1/4), SECTION 8, T 4 S, R 2 W, W.M.; 2750 FEET NORTH AND 1150 FEET EAST FROM THE SOUTHEAST CORNER OF DLC 67.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre FROM DIRECT FLOW, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
