CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of 4 WELLS in the FORT ROCK BASIN for the purpose of IRRIGATING 487.3 ACRES.

This right has been perfected under Permit G-9124. The date of priority is DECEMBER 22, 1980. This right is limited to 6.09 CUBIC FEET PER SECOND, BEING 1.58 CFS FROM WELL 1, 1.02 CFS FROM WELL 2, 1.77 CFS FROM WELL 3, 1.72 CFS FROM WELL 4 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 SW 1/4, NE 1/4 SE 1/4, SECTION 31, NE 1/4 SW 1/4, NE 1/4 SE 1/4, SECTION 32, T 26 S, R 18 E, W.M.; WELL 1 - 1300 FEET NORTH AND 1230 FEET WEST, WELL 2 - 1350 FEET NORTH AND 1400 FEET EAST BOTH FROM THE S 1/4 CORNER OF SECTION 31, WELL 3 - 1340 FEET NORTH AND 1150 FEET WEST, WELL 4 - 1360 FEET NORTH AND 1580 FEET EAST, BOTH FROM THE S 1/4 CORNER OF SECTION 32.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
