CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

R. T. RENNER ROUTE 7 LAKEVIEW, OREGON 97630

confirms the right to use the waters of DREWS CREEK AND DREWS CREEK SLOUGH, tributaries of GOOSE LAKE, for the purpose of IRRIGATING 354.4 ACRES FROM DREWS CREEK SLOUGH AND 358.6 ACRES FROM DREWS CREEK AND DREWS CREEK SLOUGH.

This right was perfected under Permit 22471. The date of priority is SEPTEMBER 8, 1941 FOR 8.08 CFS AND MAY 20, 1953 FOR 4.25 CFS. This right is limited to 12.33 CUBIC FEET PER SECOND BEING 5.03 CFS FROM DREWS CREEK, AND 7.3 CFS FROM DREWS CREEK SLOUGH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1 - SE 1/4 NW 1/4, NORTH 28 DEGREES 36 MINUTES EAST, 3654.3 FEET, 2 - SW 1/4 NE 1/4, NORTH 35 DEGREES 41 MINUTES 30 SECONDS EAST, 4803 FEET, BOTH FROM THE SW CORNER OF SECTION 20, T 40 S, R 19 E, W.M. 3 - NE 1/4 SE 1/4, NORTH 16 DEGREES 31 MINUTES WEST, 1931.9 FEET FROM THE SE CORNER OF SECTION 20, T 30 S, R 19 E, W.M. 4 - NE 1/4 SE 1/4, NORTH 5 DEGREES 12 MINUTES EAST, 148.5 FEET FROM DREWS CREEK HEADGATE 2, SECTION 20, T 40 S, R 19 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year and shall be further limited to a diversion of not to exceed 12.33 cfs.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate describes that portion of the water right confirmed by prior certificate 20626 State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on DECEMBER 9, 1988.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
