CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SPRINGS 1, 2 AND 3 AND THE NORTH UMPQUA RIVER, tributaries of THE UMPQUA RIVER, for the purpose of DOMESTIC USE FOR FIVE FAMILIES INCLUDING IRRIGATION OF LAWNS AND NONCOMMERCIAL GARDENS NOT EXCEEDING ONE-HALF ACRE IN AREA FOR EACH.

The right has been perfected under Permit 46928. The date of priority is OCTOBER 27, 1981. The right is limited to not more than 0.03 CUBIC FOOT PER SECOND WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE SPRINGS TO BE MADE UP BY APPROPRIATION OF WATER FROM THE NORTH UMPQUA RIVER or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4 SECTION 2, NW 1/4 NW 1/4 AND SW 1/4 NW 1/4 SECTION 11, T 26 S, R 3 W, W.M.; SPRING 1 - 310 FEET NORTH AND 50 FEET WEST, SPRING 2 - 230 FEET NORTH AND 40 FEET WEST, SPRING 3 - 100 FEET SOUTH AND 260 FEET EAST, RIVER - 2650 FEET SOUTH AND 660 FEET EAST; ALL FROM THE NE CORNER OF SECTION 11.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 NW 1/4 DOMESTIC 1 FAMILY  
SW 1/4 NW 1/4 DOMESTIC 4 FAMILIES  
SECTION 11  
TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
