## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES S. AND LINDA SHEA FORD 15001 NORTH APPLEGATE ROAD GRANTS PASS, OREGON 97526

confirms the right to use the waters of AN UNNAMED SLOUGH AND APPLEGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, a tributary of APPLEGATE RIVER, for the purpose of IRRIGATION OF 10.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 6.4 ACRES.

The right has been perfected under Permit 46852. The date of priority is MAY 20, 1982. The right is limited to not more than 0.125 CUBIC FOOT PER SECOND FROM THE UNNAMED SLOUGH FOR IRRIGATION AND 7.0 ACRE-FEET STORED WATER ONLY FROM APPLEGATE LAKE RESERVOIR FOR SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, SECTION 7, T 38 S, R 4 W, W.M.; 780 FEET SOUTH AND 850 FEET EAST FROM THE N 1/4 CORNER OF SECTION 7. APPLEGATE DAM - S 1/2 SE 1/4, SECTION 25, T 40 S, R 4 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre from direct flow, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The right is subject to the terms and conditions of Contract No. 2-07-10-W0464, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 NE 1/4 10.0 ACRES 6.4 ACRES
SECTION 7

TOWNSHIP 38 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
