CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PAUL G. WARES

confirms the right to use the waters of BIG CREEK AN AND UNNAMED STREAM, tributaries of THE GRANDE RONDE RIVER, for the purpose of THE IRRIGATION OF 94.0 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 8.0 ACRES.

This right has been perfected under Permit 46449. The date of priority is AUGUST 5, 1981. This right is limited to 2.55 CUBIC FEET PER SECOND, BEING 2.35 CFS FROM BIG CREEK FOR IRRIGATION AND 0.20 CFS FROM UNNAMED STREAM FOR SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, SECTION 28, T 6 S, R 42 E, W.M.; BIG CREEK-1080 FEET SOUTH AND 150 FEET WEST FROM THE NE CORNER OF SECTION 28, NW 1/4 NE 1/4, SECTION 24, T 7 S, R 41 E, W.M.; UNNAMED STREAM- 20 FEET SOUTH AND 720 FEET EAST FROM THE N 1/4 CORNER OF SECTION 24.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
