confirms the right to use the waters of the WILLIAMSON RIVER, a tributary of UPPER KLAMATH LAKE, for IRRIGATING 126.6 ACRES.

This right was perfected under Permit 23654. The date of priority is JUNE 30, 1955. This right is limited to 3.17 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 4 (SE 1/4 NW 1/4), SECTION 22, T 34 S, R 7 E, W.M.; 3930 FEET NORTH AND 2120 FEET EAST FROM THE NW CORNER OF SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
