confirms the right to use the waters of 2 WELLS in the FORT ROCK BASIN for IRRIGATING 93.8 ACRES.

This right was perfected under Permit G-8988. The date of priority is JUNE 3, 1980. This right is limited to 1.17 CUBIC FEET PER SECOND BEING; 0.08 CFS FROM WELL 6A AND 1.09 CFS FROM WELL 10, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SW 1/4 NE 1/4, SECTION 19; SE 1/4 NE 1/4, SECTION 20, T 27 S, R 19 E, W.M.; WELL 6A - 2120 FEET SOUTH AND 1910 FEET WEST FROM THE NE CORNER OF SECTION 19; WELL 10 - 1620 FEET SOUTH AND 1070 FEET WEST FROM THE NE CORNER OF SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
