CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ZX RANCH P.O. BOX 7 PAISLEY, OREGON 97636

confirms the right to use the waters of 3 WELLS in the FORT ROCK BASIN for IRRIGATING 538.1 ACRES.

This right was perfected under Permit G-6051. The date of priority is MARCH 5, 1974. This right is limited to 6.73 CUBIC FEET PER SECOND being; 2.25 cfs from well 10, 2.23 cfs from well 11 and 2.25 cfs from well 12, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 10 - SE 1/4 NE 1/4, SECTION 20, T 27 S, R 19 E, W.M.;

1620 FEET SOUTH AND 1070 FEET WEST FROM THE NE CORNER OF SECTION 20.

WELL 11 - SE 1/4 NW 1/4, SECTION 21, T 27 S, R 19 E, W.M.;

1740 FEET SOUTH AND 640 FEET WEST FROM THE N 1/4 CORNER OF SECTION 21.

WELL 12 - SW 1/4 SW 1/4, SECTION 16, T 27 S, R 19 E, W.M.;

1080 FEET NORTH AND 570 FEET EAST FROM THE SW CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
