CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of ONE WELL in the NORTH SANTIAM RIVER BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 155.6 ACRES.

This right has been perfected under Permit G-7440. The date of priority is APRIL 7, 1977. This right is limited to 4.07 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 SE 1/4 as projected within DLC 62, SECTION 35, T 9 S, R 2 W, W.M.; 3630 FEET NORTH AND 1970 FEET WEST FROM THE SE CORNER OF DLC 53.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
