CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DONALD R. AND ALICE G. GALLOGLY STAR ROUTE SILVER LAKE, OREGON 97638

confirms the right to use the waters of 5 WELLS in the FORT ROCK BASIN for the purpose of IRRIGATION OF 648.2 ACRES.

This right has been perfected under Permit G-7470. The date of priority is APRIL 26, 1977. This right is limited to 8.10 CUBIC FEET PER SECOND being 1.65 cfs from well 1, 1.59 cfs from well 2, 1.62 cfs from well 3, 1.63 cfs from well 4 and 1.61 cfs from well 5 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SW 1/4 NW 1/4, SECTION 27, NW 1/4 NE 1/4, SW 1/4 NW 1/4, SE 1/4 SW 1/4, NW 1/4 SE 1/4, SECTION 28, T 26 S, R 16 E, W.M. WELL 1 - 1320 FEET NORTH AND 1350 FEET EAST FROM THE SW CORNER OF SECTION 28; WELL 2 - 1340 FEET SOUTH AND 1150 FEET EAST FROM THE NW CORNER OF SECTION 28; WELL 3 - 1310 FEET SOUTH AND 1300 FEET EAST FROM THE NORTH 1/4 CORNER OF SECTION 28; WELL 4 - 1330 FEET NORTH AND 1300 FEET EAST FROM THE SOUTH 1/4 CORNER OF SECTION 28; WELL 5 - 2660 FEET NORTH AND 1240 FEET EAST FROM THE SW CORNER OF SECTION 27.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
