CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WARMSPRINGS IRRIGATION DISTRICT
P.O. BOX 667
VALE, OREGON 97918

confirms the right to use the waters of WILLOW CREEK, a tributary of MALHEUR RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 397.6 ACRES.

This right has been perfected under Permit 43331. The date of priority is APRIL 10, 1978. This right is limited to 9.9 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 5 (SW 1/4 NW 1/4) SECTION 6, T 18 S, R 45 E, W.M.; 530 FEET NORTH AND 110 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 6.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
