CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELLS 1, 2, AND 3 in the WILLAMETTE RIVER BASIN for the purpose of IRRIGATION OF 57.0 ACRES.

The right has been perfected under Permit G-8459. The date of priority is NOVEMBER 1, 1978. The right is limited to not more than 0.71 CUBIC FOOT PER SECOND, BEING 0.24 CFS FROM WELL 1, 0.34 CFS FROM WELL 2, AND 0.13 CFS FROM WELL 3, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 NE 1/4 AS PROJECTED WITHIN DLC 39, NW 1/4 NE 1/4, NE 1/4 NW 1/4, BOTH AS PROJECTED WITHIN DLC 46, WELL 1 - 1100 FEET SOUTH AND 3540 FEET EAST, WELL 2 - 1100 FEET SOUTH AND 2700 FEET EAST, WELL 3 - 550 FEET SOUTH AND 1600 FEET EAST, ALL FROM THE NW CORNER OF SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
