CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL A WHEN AVAILABLE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM WELL A TO BE MADE UP BY APPROPRIATION FROM WELL B in the COQUILLE RIVER BASIN for the purpose of IRRIGATION, TEMPERATURE CONTROL, AND FLOOD HARVESTING OF CRANBERRIES ON 1.95 ACRES.

The right has been perfected under Permit G-10520. The date of priority is JULY 15, 1985. The right is limited to not more than 0.3 CUBIC FOOT PER SECOND; BEING 0.05 CFS FOR IRRIGATION AND 0.3 CFS FOR TEMPERATURE CONTROL AND 0.1 CFS FOR FLOOD HARVESTING OF CRANBERRIES, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 SW 1/4, SECTION 28, T 28 S, R 14 W, W.M.; WELL A - 2950 FEET SOUTH AND 2150 FEET EAST, WELL B - 2870 FEET SOUTH AND 2140 FEET EAST, BOTH FROM THE NW CORNER OF SECTION 28.

If for irrigation of cranberries, this appropriation shall be limited to 1/40 of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. If for irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SW 1/4 1.95 ACRES
SECTION 28
TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
