confirms the right to use the waters of WELLS 1 AND 2 in the COLUMBIA RIVER BASIN for the purpose of IRRIGATING 3.15 ACRES.

The right has been perfected under Permit G-10645. The date of priority is MAY 7, 1986 FOR 0.03 CUBIC FOOT PER SECOND AND JULY 21, 1986 FOR 0.01 CFS. The right is limited to not more than 0.04 CUBIC FOOT PER SECOND FROM WELL 1 WITH ANY DEFICIENCY IN SUPPLY TO BE FURNISHED FROM WELL 2 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 38, LOT 1 (NE 1/4 SE 1/4), SECTION 17, T 2 N, R 13 E, W.M.; WELL 1 - 820 FEET NORTH AND 1130 FEET WEST, WELL 2 - 1510 FEET NORTH AND 320 FEET WEST, BOTH FROM THE SE CORNER OF SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 1 (NE 1/4 SE 1/4) 0.05 ACRE LOT 6 (SW 1/4 SE 1/4) 0.40 ACRE LOT 7 (SE 1/4 SE 1/4) 0.20 ACRE SE 1/4 SE 1/4 2.50 ACRES
