CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES D. AND BETTY R. DUNN

confirms the right to use the waters of ALLEN AND MCKAY CREEKS, tributaries of THE CROOKED RIVER, for THE IRRIGATION OF 34.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 16.5 ACRES.

This right was perfected under Permit 40642. The date of priority is MAY 17, 1976. This right is limited to 1.28 CUBIC FEET PER SECOND, BEING 0.86 CFS FROM ALLEN CREEK AND 0.42 CFS FROM MCKAY CREEK or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

ALLEN CREEK: NW 1/4 SE 1/4, SECTION 28, T 13 S, R 16 E, W.M.; 2010 FEET NORTH AND 1440 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 28. MCKAY CREEK: SW 1/4 SE 1/4, SECTION 28, T 13 S, R 16 E, W.M.; 430 FEET NORTH AND 2040 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 28.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
