CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A SUMP WHEN AVAILABLE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE SUMP TO BE MADE UP BY APPROPRIATION FROM A WELL in the COOS RIVER BASIN for the purpose of IRRIGATION, TEMPERATURE CONTROL AND FLOOD HARVESTING OF CRANBERRIES, FOR 3.8 ACRES.

The right has been perfected under Permit G-10368. The date of priority is APRIL 9, 1984. The right is limited to not more than 0.570 CUBIC FOOT PER SECOND BEING 0.10 CFS FOR IRRIGATION, 0.570 CFS FOR TEMPERATURE CONTROL AND 0.19 CFS FOR FLOOD HARVESTING or its equivalent in case of rotation, measured at the well.

The sump and well are located as follows:

SE 1/4 NE 1/4, SECTION 4, T 28 S, R 14 W, W.M.; SUMP - 350 FEET NORTH AND 700 FEET WEST, WELL - 710 FEET NORTH AND 1335 FEET WEST, BOTH FROM THE EAST 1/4 CORNER OF SECTION 4.

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre; For flood harvesting or pest control, 0.05 cubic foot per second per acre; For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 1.1 ACRES
SE 1/4 NE 1/4 2.5 ACRES
NE 1/4 SE 1/4 0.2 ACRE
SECTION 4
TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
