CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BEAR GULCH AND BOUCHER STREAM, tributaries of COYOTE CREEK, for the purpose of DOMESTIC USE FOR FOUR FAMILIES AND IRRIGATION OF 4.6 ACRES.

This right has been perfected under Permit 37961. The date of priority is JANUARY 10, 1975. This right is limited to 0.066 CUBIC FOOT PER SECOND, BEING 0.01 CFS FOR DOMESTIC USE FOR TWO FAMILIES, 0.04 CFS FOR IRRIGATION FROM BEAR GULCH, 0.01 CFS FOR DOMESTIC USE FOR TWO FAMILIES AND 0.006 CFS FOR IRRIGATION FROM BOUCHER STREAM, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SE 1/4, SECTION 29, NE 1/4 NE 1/4, SECTION 32, T 33 S, R 5 W, W.M.; BEAR GULCH 1 - 5000 FEET SOUTH AND 3530 FEET EAST, BEAR GULCH 2 - 5100 FEET SOUTH AND 3550 FEET EAST, BOUCHER STREAM 3 - 5450 FEET SOUTH AND 3900 FEET EAST ALL FROM THE NW CORNER OF SECTION 29.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

SW 1/4 SE 1/4 4.1 ACRES AND DOMESTIC FOR 2 FAMILIES
SECTION 29
NE 1/4 NE 1/4 DOMESTIC FOR 1 FAMILY
NW 1/4 NE 1/4 0.5 ACRE AND DOMESTIC FOR 1 FAMILY
SECTION 32
TOWNSHIP 33 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
