CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of AN UNNAMED STREAM AND CUNNINGHAM CREEK, tributaries of CALLOWAY CREEK, for the purpose of IRRIGATING 8.8 ACRES, DOMESTIC USE FOR THREE FAMILIES, AND STOCK.

The right has been perfected under Permit 40381. The date of priority is NOVEMBER 25, 1975. The right is limited to not more than 0.125 CUBIC FOOT PER SECOND; BEING 0.11 CFS FOR IRRIGATION FROM CREEK AND 0.01 CFS FOR DOMESTIC AND 0.005 CFS FOR STOCK FROM STREAM or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 4 (SW 1/4 SW 1/4), SECTION 30, NE 1/4 NW 1/4, LOT 1 (NW 1/4 NW 1/4), SECTION 31, T 27 S, R 12 W, W.M.; CREEK - 60 FEET NORTH AND 1140 FEET EAST, STREAM - 1190 FEET SOUTH AND 1470 FEET EAST, CREEK - 10 FEET SOUTH AND 680 FEET EAST, ALL FROM THE NW CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 4 (SW 1/4 SW 1/4) 7.8 ACRES, DOMESTIC & STOCK
SECTION 30
LOT 1 (NW 1/4 NW 1/4) 1.0 ACRE
SECTION 31
TOWNSHIP 27 SOUTH, RANGE 12 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
