CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLENN BIRDSEYE
3793 ROGUE RIVER HIGHWAY
GOLD HILL, OREGON 97525

confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for the purpose of IRRIGATION OF 19.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 52.4 ACRES.

The right has been perfected under Permit 44982. The date of priority is JANUARY 3, 1980. The right is limited to not more than 0.9 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 41 SECTION 27, T 36 S, R 4 W, W.M.; 1210 FEET NORTH AND 130 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
