CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DON DODSON ROUTE 1, BOX 654 NORTH POWDER, OREGON 97867

confirms the right to use the waters of A SPRING, a tributary of POWDER RIVER, for the purpose of IRRIGATING 2.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 4.6 ACRES, AND STOCK WATER.

The right has been perfected under Permit 45716. The date of priority is MAY 26, 1981. The right is limited to not more than 0.18 CUBIC FOOT PER SECOND, BEING 0.175 CFS FOR IRRIGATION AND 0.005 CFS FOR STOCK WATER or its equivalent in case of rotation, measured at the point of diversion from the source.

The SPRING is located as follows:

SW 1/4 NE 1/4, SECTION 14, T 6 S, R 39 E, W.M.; 1700 FEET SOUTH AND 1300 FEET EAST FROM THE N 1/4 CORNER OF SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land. PROVIDED FURTHER THAT DURING THE IRRIGATION SEASON, THE WATER FOR STOCK SHALL BE A PART OF THAT DIVERTED FOR IRRIGATION AND SHALL NOT EXCEED 0.005 CFS FOR STOCK AT ANY TIME.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
