confirms the right to use the waters of LOST CREEK RESERVOIR CONSTRUCTED UNDER PERMIT R-8142, a tributary of ROGUE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 13.1 ACRES.

The right has been perfected under Permit 46390. The date of priority is AUGUST 10, 1981. The right is limited to not more than 14.0 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SECTION 32, NW 1/4 SW 1/4, SECTION 33, T 33 S, R 1 E, W.M.; 2 - 560 FEET SOUTH AND 1600 FEET WEST, 1 - 1120 FEET SOUTH AND 240 FEET EAST, BOTH FROM E 1/4 CORNER OF SECTION 32; LOST CREEK RESERVOIR - SW 1/4 NW 1/4 AND W 1/2 SW 1/4, SECTION 26, T 33 S, R 1 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT ALLOWED HEREIN SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT EXISTING FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN, AND IS SUBJECT TO THE TERMS AND CONDITIONS OF CONTRACT 1-07-10-W0371 BETWEEN THE BUREAU OF RECLAMATION AND THE APPLICANT, OR A SATISFACTORY REPLACEMENT, A COPY OF WHICH IS ON FILE IN THE RECORDS OF THE WATER RESOURCES DIRECTOR.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 10.6 ACRES SE 1/4 NE 1/4 0.2 ACRE SE 1/4 NW 1/4 1.0 ACRE NE 1/4 SE 1/4 1.3 ACRES

SECTION 32

TOWNSHIP 33 SOUTH, RANGE 1 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
