CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STRAUS RANCHES 10613 TABLE ROCK ROAD CENTRAL POINT, OREGON 97502

confirms the right to use the waters of UNNAMED STREAM 1 WHEN AVAILABLE, WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM UNNAMED STREAM 1 TO BE MADE UP BY APPROPRIATION FROM STREAM 2, a tributary of LITTLE BUTTE CREEK, for the purpose of IRRIGATION OF 4.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 23.58 ACRES.

This right has been perfected under Permit 48316. The date of priority is JANUARY 10, 1984. This right is limited to 0.35 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, SE 1/4 NW 1/4, BOTH AS PROJECTED WITHIN DLC 47, SECTION 10, T 36 S, R 1 W, W.M.; STREAM 1 - 380 FEET SOUTH AND 2050 FEET WEST, STREAM 2 - 1390 FEET SOUTH AND 3060 FEET WEST, BOTH FROM THE NE CORNER OF SECTION 10.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

NW 1/4 NE 1/4 NE 1/4 NW 1/4 PRIMARY 4.6 ACRES

SUPPLEMENTAL 12.5 ACRES

11.08 ACRES

BOTH AS PROJECTED WITHIN DLC 47

SECTION 10

TOWNSHIP 36 SOUTH, RANGE 1 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
