CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARVIN PADBERG  
IONE, OREGON 97843

confirms the right to use the waters of WELL NO. 2, in the RHEA CREEK BASIN for the purpose of IRRIGATING 522.6 ACRES.

This right has been perfected under Permit G-8701. The date of priority is APRIL 19, 1978. This right is limited to 5.2 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NE 1/4, SECTION 35, T 1 S, R 24 E, W.M.; 1180 FEET SOUTH AND 620 FEET WEST FROM THE NE CORNER OF SECTION 35.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
