CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TEN WELLS in the WILLAMETTE RIVER BASIN for MUNICIPAL PURPOSES. THESE WELLS ARE LOCALLY KNOWN AS THE JAN REE AND HAYESVILLE WELLS.

This right was perfected under Permit G-8558. The date of priority is MAY 3, 1979. This right is limited to 12.06 CUBIC FEET PER SECOND, BEING 1.40 CFS FROM JAN REE WELL 1, 1.50 CFS FROM JAN REE WELL 2, 1.10 CFS FROM JAN REE WELL 3, 1.25 CFS FROM JAN REE WELL 4, 1.10 CFS FROM JAN REE WELL 5, 1.70 CFS FROM JAN REE WELL 6, 1.25 CFS FROM JAN REE WELL 7, 1.35 CFS FROM JAN REE WELL 8, 0.55 CFS FROM HAYESVILLE WELL 1, AND 0.86 CFS FROM HAYESVILLE WELL 2, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

JAN REE WELL 1 - NE 1/4 NW 1/4, SECTION 7, 220 FEET SOUTH AND 940 FEET EAST FROM NW CORNER DLC 40; JAN REE WELL 2 - SE 1/4 SE 1/4, SECTION 6, 340 FEET NORTH AND 1090 FEET WEST, JAN REE WELL 3 - SE 1/4 SE 1/4, SECTION 6, 620 FEET NORTH 720 FEET WEST, JAN REE WELL 4 - SW 1/4 SE 1/4, SECTION 6, 670 FEET NORTH AND 2500 FEET WEST ALL FROM SE CORNER SECTION 6; JAN REE WELL 5 - SW 1/4 SW 1/4, SECTION 5, 1220 FEET NORTH AND 50 FEET EAST FROM SW CORNER SECTION 5; JAN REE WELL 6 - SE 1/4 SE 1/4, SECTION 7, 600 FEET WEST AND 170 FEET NORTH FROM SE CORNER SECTION 7; JAN REE WELL 7 - SE 1/4 SW 1/4, SECTION 6, 1800 FEET SOUTH AND 800 FEET EAST FROM NE CORNER LOT 2, SECTION 6; JAN REE WELL 8 - NW 1/4 NW 1/4, SECTION 17, 940 FEET SOUTH AND 1000 FEET EAST FROM THE NW CORNER SECTION 17; HAYESVILLE WELL 1 - LOT 2 (NW 1/4 SW 1/4), SECTION 6, 500 FEET SOUTH AND 460 FEET WEST, HAYESVILLE WELL 2 - LOT 3 (SW 1/4 SW 1/4), SECTION 6, 1250 FEET SOUTH AND 1010 FEET WEST BOTH FROM THE NE CORNER LOT 2, SECTION 6; ALL IN T 7 S, R 2 W, W.M.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

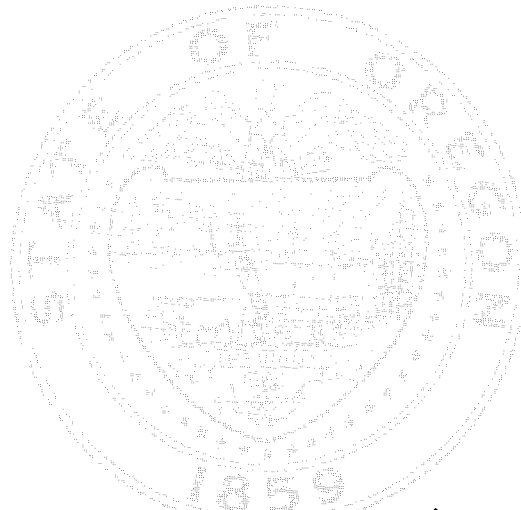
